<u>SUMMARY</u>

City staff produces an updated Capital Improvement Plan (CIP) annually, which is brought before the City Council for approval. The document is also brought annually before the Planning Commission to make a finding that the Plan is in conformance with the City of Moreno Valley's General Plan.

PROJECT DESCRIPTION

The intent of the Fiscal Year (FY) 2015-2016 Proposed CIP is to identify the various capital improvements and funding sources over the next fiscal year and to establish a capital improvement plan over the next five years and beyond, to build-out, as referred to in the general plan use and circulation plans. The document is grouped by

categories and by fund and includes a detailed project sheet for every project that is requesting carryover funds or new funds for FY 2015-2016. All of the CIP project sheets provide an estimate of total project cost and anticipated fiscal year of construction. The CIP also focuses on establishing funding sources and the availability of funds during the anticipated fiscal year of construction.

The document is designed to be a five year progressive document that is revised annually as part of the budget adoption process. The FY 2015-2016 Proposed CIP begins with the capital budget year 2015-2016 and extends to "FY 2019-2020 and Beyond." All projects listed in the "FY 2016-2017" through "FY 2019-2020 and Beyond" timeframe are typically unfunded and will be brought forward as community needs arise.

Specifically, the elements of the CIP reflect the ultimate goals of the General Plan to achieve a community which:

- Provides public services and public facilities that are needed and desired by the community.
- Provides recreational amenities, such as parks, multi-use trails, and community centers.
- Provides a circulation system that fosters traffic safety and the efficient movement of motor vehicles, bicycles, and pedestrians.
- Provides emphasis on public health and safety, including police, fire, emergency, and animal services facilities, and protection from floods and other hazards.

The streets, bridges, buildings, drainage facilities, and traffic signals listed in the FY 2015-2016 Proposed CIP are consistent with the General Plan. The parks projects listed meet the three acre per one thousand population standard set forth in the General Plan.

REVIEW PROCESS

Staff has had numerous meetings with all City Departments since December 2014 in an effort to prepare a complete capital budget and FY 2015-2016 Proposed CIP. Staff has also met with each Council member individually to obtain their feedback early on in the CIP preparation process. The document has been available for public review since April 27, 2015. The Planning Commission's action tonight is time critical because the FY 2015-2016 Proposed CIP is tentatively scheduled to be presented to the City Council on June 9, 2015, for adoption as part of the City's FY 2015-2016 budget.

ENVIRONMENTAL

The FY 2015-2016 Proposed CIP is not a project as defined under the California Environmental Quality Act (CEQA) in that the Proposed CIP is a fiscal activity that would not involve any commitment to any specific project, that may result in a potentially
