G.1. MORENO VALLEY LOGISTICS CENTER PEN16-0001 THROUGH PEN16-0007: THE APPLICANT IS SEEKING APPROVAL OF A SPECIFIC PLAN AMENDMENT TO MODIFY THE BUFFERING AND LANDSCAPING

March Joint Powers Commission (JPC)

Mayor Pro Tem Baca provided an update on the March Joint Powers Commission meetings held on September 21st and 27th.

In those meetings, the Commission:

- Approved several actions related to a Parcel Delivery Terminal on 126.2 acres at 20801 Krameria within Meridian Business Park, South Campus,
- Agreed to the sale of the General Old Golf Course to the Veterans Administration for \$12.5 million dollars, for the expansion of the Riverside National Cemetery, and
- Heard an update about the US Veterans Housing project. They are 76% complete with their first phase and they anticipate completion by Jan 1.

Riverside County Habitat Conservation Agency (RCHCA) - None

Riverside County Transportation Commission (RCTC)

Mayor Pro Tem Baca reported the following:

IE Commuter announced this year's Rideshare Week is October 2nd - 6th. The two biggest benefits of participating in a rideshare program are it helps the environment and saves money. However, many solo drivers still need an extra incentive to give it a try, so IE Commuter is incentivizing commuters to "Go Green, Save Green".

Commuters can sign up and pledge to take the bus, train, carpool, vanpool, bike or walk to work at least one day during Rideshare Week and have the opportunity to win great prizes.

IE Commuter is a program of the Riverside County Transportation Commission with the objective to reduce traffic and improve air quality throughout the region. For more information, please visit IECommuter.org, or call 1-866-RIDESHARE.

Western Riverside Council of Governments (WRCOG)

Mayor Gutierrez provided the update as follows:

Items covered at the Western Riverside Council of Governments Executive Committee meeting on October 2, 2017:

- The Western Riverside Energy Partnership announced the 4th Annual LED Holiday Light Exchange and Energy Efficiency starter kit give-away where SCE/SoCal Gas customers can exchange old incandescent string lights for new energy-efficient LED holiday lights at no cost. A give-away will occur on December 9th at the Moreno Valley Snow Day and Holiday Tree Lighting ceremony.
- WRCOG will enter into an agreement with PlaceWorks consulting to perform a feasibility analysis for EXPERIENCE, a sustainability demonstration center. The intent of EXPERIENCE is to showcase the strides inland southern California has made towards achieving a more sustainable quality of life, and to empower visitors to institute more sustainable practices into their homes, schools, and businesses.
- WRCOG is finalizing several documents related to the implementation of the TUMF Program, including an updated Fee

Calculation Handbook and TUMF Reimbursement Manual. Both documents will be reviewed and approved by WRCOG Committees before the end of the year.

Western Riverside County Regional Conservation Authority (RCA)

Council Member Giba provided the update as follows:

- The Local Development Mitigation Fee collection for the month of August totaled \$1,648,699 which is utilized to purchase land to preserve species and organisms both plant and animal. For the month of July the city of Moreno Valley collected fees amounting to \$297,184, only second to the city of Riverside with a total of \$674,920. These fees are collected from developers for mitigation purposes.
- Resolution No. 2017-006, a resolution of the Board of Directors of the Western Riverside County Regional Conservation Authority declaring support for the establishment of a national wildlife refuge within the boundaries of the Western Riverside County Multiple Species Habitat Conservation Plan was recently passed. To date 56,000 acres have been acquired so far, which is 30% of the number needed, amounting to 37% of the total acquisitions required.

School District/City Joint Task Force - None

Southern California Association of Governments (SCAG)

Council Member Giba provided the update as follows:

- Members of the public were invited to join him in Los Angeles and attend the three major Southern California Association of Governments council meetings.
- The SCAG Legislative Action Committee met on a variety of things.
 The majority of the legislation examined concerns transportation.
- The League of Cities Legislative Action Committee is meeting this Wednesday, where several bills will be reviewed. The League of California Cities is more concerned with a variety of issues that affect our cities.
- At the November 14th Study Session Lucy Jones, the earthquake lady, will be presenting on earthquake preparedness.
- SCAG has launched a new initiative, entitled the Earthquake

Preparedness Initiative, to help local cities and counties protect Southern California communities and economies from the disruption that a major earthquake would cause.

- 4. Residents have made her aware that they are receiving citations from Code Enforcement for their lawns which they let die in an effort to help conserve water. Requested a report be made available at the next meeting with possible solutions.
- 5. Proud of the direction the City is headed and encouraged all to visit Moreno Valley establishments.
