

# Economic development focused infrastructure review



### Study Area City Infrastructure

- Circulation improvements (streets, sidewalks)
- Traffic control devices
- Storm drain
- Bridges/interchanges
- Fire stations
- Electrical

## Study Area Non-City Infrastructure

- Sewer
- Water
- Telecom (quantities/estimates not included)

### **Exclusions**

- Existing pavement rehabilitation
- Post construction maintenance
  - Additional staffing/equipment
- ► Aesthetic enhancements (e.g. decorative medians, wayfinding signs)
- Existing utility undergrounding (e.g. SCE overhead lines)
- MVU facilities due to Electric Rule 15
- Landscaping in rights-of-way
- ▶ Trails/parks
- Post construction NPDES requirements

### **Estimated Quantities**

### Study Area:

- ▶ 30 centerline miles of arterial street improvements: \$220M
- ▶ 47 traffic control devices (signals/round-abouts): \$27M
- 24 miles of storm drain improvements: \$84M
- 3 bridges/overpasses/interchanges: \$215M
- ▶ 2 Fire Stations: \$15M
- MVU: \$52M (Rule 15 excluded)

# Rough Order Magnitude Cost Estimates

- ► \$561M City total
  - ► Includes soft costs (e.g. engineering and environmental documents)
  - Includes estimates for right of way acquisition
  - ▶ Does not include time-value of money or inflation (20 years buildout estimate)
- \$362 EMWD (sewer/water)
  - Info provided by EMWD fair-share studies

### Example

### City of Irvine Examples

- ► Irvine Business Complex (2,600 acres) approx. \$220M infrastructure
  - Mitigation Fee program (allows for use of other money)
  - Vehicle trip generation concept
  - ▶ Paid by developer(s); eligible for outside grants
  - Most backbone infrastructure built by developer(s)
  - City projects using collected fees
- ► Keys long-term maintenance and safety vision IBC plan
  - CFDs
  - LLMD
  - Assessment Districts

## Example

### City of Irvine Examples

- Irvine Great Park
  - Community Facilities District (CFD) secured
  - Developer installed backbone; occupancy occurs
  - Bonds issued used to reimburse developer
  - Tax paid by property owners in the District

## Example

San Diego Enhanced Infrastructure Financing District

- Otay Mesa Community Plan Area
  - Tax Increment secured
  - State Controller review (review of Successor Agency)
  - Other taxing entities involvement
  - Governed by Public Financing Authority (3 elected/2 public)
  - Voter approved bonding

### **Examples**

### City of Moreno Valley

- ► CFD 7 (south)
  - ► CFD secured (approx. 2008)
  - Developer installed backbone; occupancy occurs
  - ► Bonds issued (2016) used to reimburse developer
  - ► Tax paid by property owners in the District
- South industrial area no area wide CFD
  - Developer installed
  - DIF credit
- Ongoing Districts for maintenance
  - Landscaping
  - NPDES
  - Street lights

## **Funding Options**

- Special Districts (property owners in the Study Area)
  - ► CFD (infrastructure or maintenance); qualified electors approval (i.e. vote)
  - ► LLMD (maintenance); requires GB funding; vote
- Infrastructure Financing District; county/city approved; property tax increment
- Debt Service/Bonding General Fund obligation
- Mitigation fee (overlay)
- Combination of above
