- Tier II: hired on or after 7/1/09 - City pays employer contribution / employee pays 8% employee contribution (2.7% @ 55)
- Tier III: hired on or after 12/23/11 - City pays employer contribution / employee pays 7% employee contribution (2% @ 55)
- Tier IV: new members hired on or after 1/1/2013 - City pays employer contribution / employee pays 6.25% employee contribution (2% @ 62)
