



## **Commercial Energy Audit & Direct Install Program Application**

The program provides eligible small- or medium-sized business customers with an energy audit and specific recommendations for their business plus a fixed set of maintenance and upgrades provided at no cost to the customer up to a value of \$3,000. This program is only available to qualified businesses that have electrical demand that does not exceed 100 kW for three consecutive months in a twelve-month period. The program is provided on a first-come, first-served basis until program funds are no longer available. This program may be modified or terminated without prior notice.

MVU will send a certified energy management contractor to the customer's facility to conduct and onsite energy audit and will prepare and provide an audit report listing recommended retrofits and behavioral change measures. Each recommendation will include the cost to perform the retrofit, anticipated annual energy savings, and simple payback. Customers can select recommendations to be installed and MVU's certified installers will conduct the work at the facility.
