ADOPT-A-ROAD PROGRAM SUMMARY

What is Adopt-A-Road?

The Adopt-A-Road program allows community volunteers to assist in the beautification of neighborhoods throughout the City of Moreno Valley through litter removal along City roads. The Adopt-A-Road program maximizes our community's resources with a focus on litter abatement.

What roads can be adopted?

Predesignated segments of road within the City of Moreno Valley have been identified for adoption. In this packet, you will find a list and description of the City of Moreno Valley road segments which are eligible for adoption.

Who can Adopt-A-Road?

- Individuals
- Schools
- Church groups
- Service clubs
- Local businesses
- Youth groups
- Scouts

What can volunteers do?

- Remove litter from the public right-of-way along adopted road segments.
- All program participants and volunteers will be required to register as a City volunteer.
- Check out supplies, such as litter grabbers, gloves, safety vests, and trash bags, from the City for related Adopt-A-Road program clean ups.

What will the City do?

- Work with the volunteer groups and/or individuals to identify appropriate volunteer assignments.
- Loan out supplies, such as litter grabbers, gloves, safety vests, and trash bags to volunteer groups and/or individuals upon request for related Adopt-A-Road program clean-ups.

PARTICIPANT RESPONSIBILITIES

- 1. Prior to the first clean-up, all participants must submit their volunteer name or group name artwork for the volunteer recognition panel. The panel will be installed on the Adopt-A-Road sign for the adopted segment of road.
- 2. All participants must complete a Volunteer Application.
- 3. All participants must sign a City Waiver and Release form.
- 4. Participate in a mandatory 15 minute safety orientation prior to the first clean-up. Supplies cannot be borrowed unless the safety orientation is completed by the volunteer leader or coordinator.
- 5. On approved date(s), clean trash and debris from the public right of way along the adopted segment(s) of road.
- 6. All minors must be supervised by an adult.
- 7. On approved dates, clean adopted segments of road on a quarterly basis, or at least four times per year.
- 8. Report any issues along the adopted segment of road (broken irrigation, graffiti, etc.) to Maintenance and Operations (951. 413.3160) during clean-up activities.



CITY RESPONSIBILITIES

- 1. Identify adoptable road segments throughout the City of Moreno Valley.
- 2. Review Adopt-A-Road volunteer applications.
- 3. Assign approved Adopt-A-Road volunteers to specified road segments.
- 4. Track road segments and assigned volunteers.
- 5. Forward sign placard with the volunteer name or group name for Department Head approval.
- 6. Once approved, manufacture the sign placard and install on the Adopt-A-Road sign for the adopted segment of road.
- 7. Evaluate requested clean-up dates to determine if there are potential conflicts with City events, construction activities, etc. prior to approving the clean-up event.
- 8. Document, monitor, and track clean-up event dates and locations for each program participant.
- 9. Conduct safety orientation and distribute clean-up materials.
- 10. Monitor and track reported cleanings by program participants for assigned road segment(s).
- 11. Ensure that minimum quarterly cleaning standards are being met. If minimum cleaning standards are not being met, remind volunteers of program requirements to maintain actively enrolled in the program.
- 12. Track and address any complaints associated with program participants or clean-up activities.
- 13. Monitor, track, distribute, and recover supplies borrowed from the City by volunteers to ensure maximum recovery. Report damaged supplies after clean-up events.
- 14. Monitor supplies and operating budget, order additional supplies as resources, demand, and budget permit.
- 15. After completion of the second clean-up, create a sign placard with the volunteer name or group name for Department Head approval.
- 16. Once approved, manufacture the sign placard and install on the Adopt-A-Road sign for the adopted segment of road.
- 17. Install and maintain Adopt-A-Road signs along adoptable road segments.
- 18. Remove sign placards for participants no longer participating in the program and make the associated segment of road available for adoption.



SAFETY GUIDELINES

- 1. Stay clear of all construction areas.
- 2. Work is to be completed during daylight hours.
- 3. Always provide adult supervision for your organization/group.
- 4. Place all bagged litter/trash at the designated locations to ensure pick-up. Notify Maintenance and Operations for pick-up (951.413.3160). Maintenance and Operations supplies trash bags.
- 5. Be aware of snakes, bees, wasps, ants and spiders.
- 6. Have a first-aid kit available on site in case of an emergency.
- 7. No work shall be performed during inclement weather. *Inclement weather shall mean the existence* of rain, or abnormal climatic conditions (whether they be those of hail, snow, cold, high wind, sever dust storm, extreme high temperature or any combination thereof) by virtue of which it is either not reasonable or not safe for volunteers exposed thereto to continue working whilst the same prevail.
- 8. Do not remove hazardous substances (e.g., car batteries, needles, or pesticide containers). Notify Maintenance and Operations (951.413.3160) if these substances are found.
- 9. Avoid contact with noxious weeds (poison oak, sumac). Report any weed growth to Maintenance and Operations (951.413.3160). Do not apply any weed killers.
- 10. If you are near a roadside, work facing on-coming traffic.
- 11. Cross roads only in cross walks.
- 12. Do not wear earphones while working.
- 13. Wear clothing that is appropriate for the task at hand and current weather conditions.
- 14. Wear gloves, safety vests, and closed toed shoes at all times.
- 15. Work in a buddy system at all times. Look out for each other. Have access to communications (phone, 2-way radio) at all times.

It's important to call the Maintenance and Operations Division immediately following a clean-up project and leave a message with the exact location of the trash bags so staff can arrange for timely pick-up and disposal. Thank you for helping us Keep Moreno Valley Beautiful.




VOLUNTEER RECOGNITION PANEL ARTWORK

FILE SUBMISSION REQUIREMENTS:

All participants must submit completed artwork along with a volunteer application and waiver. An artwork proof example is attached below for guidance.

- 1. The volunteer recognition panel artwork must be submitted as a vector file (Al CS6 and below, high res PDF, EPS, Corel Draw 12, Flexi 7). Vector artwork saved as/exported as a PDF is an acceptable PDF format.
- 2. The artwork file should be submitted in actual size or proportionate to final size. The volunteer panel measures 30L x 7W
- 3. All fonts should be included or converted to curves/outline.
- 4. The file should be created or converted to CMYK mode. CMYK refers to the four inks used in the color printing: cyan, magenta, yellow, and key (black). If matching colors is crucial, include CMYK specifications.
- 5. Provide 1/8"" extra all around bleed.
- 6. Any images or logos included in the artwork must be submitted in a separate vector file, in actual size and 300 dpi or higher.
- 7. Plain text is an option available if there is no existing logo/design in place.
