# Mandatory Recycling For Businesses & Multi-Family Complexes



**Did You Know?** California's Mandatory Commercial Recycling Law (AB 341), requires businesses and multi-family properties to recycle.

COMMERCIAL RECYCLING (AB 341)

Businesses that generate at least four cubic yards of solid waste per week and multi-family properties with five units or more, must have a recycling program in place.



**Did You Know?** California's Mandatory Organic Waste Recycling Law (AB 1826), requires businesses and multi-family properties to arrange for organic waste recycling services.

ORGANICS RECYCLING (AB 1826)

Businesses and multi-family properties of five units or more, that generate four cubic yards of solid waste per week, must have organic waste recycling services. Multi-family properties must recycle yard waste but are not required to recycle food waste.



### **Current Regulations**

Since January 2017, businesses that generate 4 cubic yards or more of organics waste a week must subscribe to organics collection. As of January 1, 2019, businesses that generate 4 cubic yards or more of solid waste per week must have organic waste recycling services. Beginning January 1, 2020, businesses that generate 2 cubic yards or more of solid waste per week must have organic waste recycling services, if statewide disposal of organic waste is not decreased by half.

- Eggs
- Plants and Cut Flowers
- Grass Clippings
- · Leaves, Weeds



#### **UNACCEPTABLE ITEMS**

- Plastic Food Packaging/Wrap
- Latex and Plastic Gloves
- Coated and Plastic Take-out Containers (generally includes all cups)
- Paper Products (napkins, paper towels)
- Waxed Products: Corrugated and Paper
- Plastic Bags
- · Glass Bottles and Jars
- Aerosol Cans
- · Metal, Foil
- Polystyrene
- Twist Ties, Rubber Bands, Wire
- Tape, Rope, Twine
- Grease and Oil
- Liquids
