**By choosing to participate in the residential Electric Vehicle Discount Program, you agree to the following conditions and terms:**

1. The program is limited Moreno Valley Utility residential customers and to one (1) vehicle per service location.
2. The utility services must be in the program applicant's name and registered owner's or lessee's name
3. The discount is non-transferable. A change in ownership, location, or vehicle requires a new application.
4. A copy of the current DMV Vehicle Registration noting dates/period covered must be provided. Participants must notify the City of Moreno Valley Utility within 30 days if the qualifying vehicle is sold.
5. Fraud and/or misrepresentation of facts for the purpose of qualifying for the Electric Vehicle Discount Program will result in program disqualification and reversal of prior discounts.
6. Once the initial application is approved, a copy of the renewed vehicle registration is required each subsequent registration year to avoid a discount lapse. It is the applicant's responsibility to re-apply. Discounts will cease upon expiration of the current registration unless a copy of the renewed registration is received by the City. Discounts are not retroactive.
7. Incomplete applications will be denied pending resubmission of a fully completed version.
8. The election to participate in the program is at the sole discretion of the customer.

## **Electric Vehicle Discount Terms and Conditions**

*Providing Qualifying Residential Utility Customers with Discounted Electric Rates*

### **Program Qualifications**

- You have a current City of Moreno Valley Utility residential electric utility account in your name, and
- You provide a current copy of the DMV registration for the electric vehicle, and
- The vehicle is registered to the electric utility account holders name and service address and is garaged at this service address.
- Customer may be on the Residential Rate A or Residential Rate B.
- Charging of vehicle shall be done primarily in the off-peak period between 9pm and 4pm the following day.

### **Discount Schedule:**

The discount applies to up to a maximum of 500 kWhs per month, shall be discounted by 5 cents per kWh per billing period. Opening and Closing bills shall be prorated.

### **Conditions for Participation:**

- The program only applies to City of Moreno Valley Utility residential electric utility customers.
- The program is limited to one (1) vehicle per service location.
- The utility services must be in the program applicant's and registered owner's/lessee's name.
- Discount benefits are non-transferrable and will NOT transfer to a new residence. When or if the applicant moves, or has a new vehicle, a new application is required in both cases.
- Current proof of the DMV Vehicle Registration must be provided which indicates the dates and period covered.
- Participants must notify the City of Moreno Valley Utility within 30 days if the qualifying vehicle is sold or no longer garaged at the service address.
- Fraud and/or misrepresentation of facts for the purpose of qualifying for the Electric Vehicle Discount Program will result in program disqualification and reversal of prior discounts.

### **Program Terms:**

- The election to participate in the program is at the sole discretion of the customer and any impact on billing remains' the sole responsibility of the customer.
- A copy of the renewed vehicle registration is required each subsequent registration year to avoid a discount lapse. It is the applicant's responsibility to re-apply. Discounts will cease upon expiration of the current registration unless a copy of the renewed registration is received by the Moreno Valley Utility in advance of expiration.
- Electric vehicle may be owned or leased.
- Discounts are not retroactive.
